Dear Parents:

**Welcome** to the registration process for a new school year! As always, enrolled families are given first consideration, and new families are welcome to come in for a tour anytime. All families should return the attached application form to apply / pre-register and reserve a schedule in the program for Summer and/or Fall 2012. You can apply online at [www.pccpduxbury.org](http://www.pccpduxbury.org) and there are flexible scheduling options for each program.

**Prepayments** will be required once an opening is confirmed. For enrolled families, the prepayment is invoiced at the scheduled completion of your current contract. For new families, all programs require a tuition deposit of either \$250.00 (1-3 day reservations) or \$500.00 (4-5 day reservations). The deposit is applied to the last month of your contract. Any overage is applied to your first month of tuition. A payment plan is available if needed.

**Summer Camps** will be offered for ages 3 years and up. Priority is given to full summer applicants (a 10-week program). The Camp program includes onsite guests, walks to Snug Harbor, academic enrichment, lessons at the Kingsbury Club, Ecology and Ocean experiences with the Duxbury Maritime School and more. It is an advantageous program for healthy child development.

Infant and Toddler families (all families) will find summer is a great opportunity to begin enrollment at Pilgrim.

**Enrollment decisions** are mailed on or before February 1. Openings are available on a first come first serve basis. Your questions are important. Please contact us at any time about programs that best suit your family needs. Please review the attached information and come by any time to visit.
